Theta's Crossroads

believe the Theta chapter's future is at a crossroads. On the eve of the chapter's 150th anniversary, we are faced with decisions that are equal in magnitude to the decision to disband the chapter. I will always agree that the alumni made the right decision even though many may have thought otherwise. The chapter was a risk and had no real hope of correcting all the operational issues it faced.



I know that the closure of the chapter

and how it was handled has led to some skepticism and mistrust of the Ohio Wesleyan University administration, but we must not dwell on the past and instead look to the future. The future that I hope for is one that has an active chapter in Delaware, Ohio.

We have been lucky because we have been able to sustain communication between alumni since the chapter's disbandment. Eventually this communication will begin to wither without continual chapter activity. I have begun to sense that we have seen the peak and have begun the downward slope of communication. If we lose communication between alumni we will be stuck in a difficult position, one that makes recolonization nearly impossible.

Can we have a successful return to Ohio Wesleyan? Yes, we can have a stronger chapter, one that we all can be proud of if we work together and one that will be fully partnered with the Men of Principle Initiative. Upon our initiations we took seven obligations to which we willingly agreed. One obligation was that we would forever uphold the Theta chapter as a chapter of Beta Theta Pi. It is now time that we once again pledge ourselves to this obligation.

So how do we go about recolonizing the chapter? The first step is that we must strengthen the lines of communication between our members while reconnecting with the General Fraternity and Ohio Wesleyan University. Discussions need to take place about the future of the chapter between our alumni. Further we must keep communicating with the administration, both Dean Delaney and the new staff members in charge of Greek Affairs and develop with them a plan to return to campus. The second step is that we must have dedicated alumni who are willing to serve as advisors for the chapter once it is recolonized. The advisors will help the chapter achieve long term success by mentoring the undergraduate members. The advisory team can be developed as we move along in the process.

There are many questions that surround a recolonization at OWU. For instance, is a chapter house necessary? Many would say yes, I say no. Beta Theta Pi has had many successful colonies start without housing. Nowhere does it say that a chapter of Beta Theta Pi is a sole product of its house. The house is just bricks and mortar while the chapter consists of men. The chapter is the more important of the two. Another question is, how will we be received if we start recolonization efforts? That is a question I do not have the answer for, but that is why it is so important to stay involved with the University. We have a number of things that will help us. We are the first fraternity to be founded at OWU. We have had numerous alumni who have played important roles in both the Fraternity and the University. We will bring something new to the campus a fraternity who is grounded in the values of their organization and whose members truly are about bettering themselves and the community.

Which way will the Theta chapter take at the crossroads? Will it return to prominence at OWU or will it stay dormant for many years to come? The bottom line is that if we want the chapter to return, the drive must come from us, the members of the Theta chapter. I will forever uphold the Theta chapter as a chapter of Beta Theta Pi. This year has been a good one for us from a fund raising point of view. The Eiken litho of 54 W. Lincoln house generated considerable interest. We have entered this year with \$7500 in the bank. We have terminated our relationship with Affinity Connection. They did a good job of database management, printing and distributing *Theta Data*. However, their services came at a considerable price. We typically spent \$6000-\$8000 per year with them. Your board has decided that we can use the General Fraternity's database for mailings, send alumni updates to them, and publish *Theta Data* ourselves using desktop publishing software. That way our costs will be reduced to actual printing and mailing cost with a small amount of outsourcing for technical help with layout and design. We think about \$2000 per issue.

Consequently, the robustness and frequency of *Theta Data* will depend on two factors — your contribution of materials for our publication and financial help. Please keep us up-to-date and *thank you* for your continued support.

Words From the Regional Director

These are exciting times for Beta Theta Pi. Our Men of Principle Initiative is receiving recognition throughout the fraternity world. Currently we have 35 (of 130) chapters that are partnered with the General Fraternity for the initiative. Partnering means that the General Fraternity commits resources (mostly manpower) each year to assist the chapters to set goals for improvement. These resources include facilitators, scholarships, recruitment guidance,



a planning structure and Beta versions of the Franklin-Covey planner for each member. In return, the chapters agree to abide by all the standards of the fraternity (alcohol free rush, no hazing, and scholarship). They also agree to maintain 5 active advisers in key areas—chapter counselor, financial adviser, risk management adviser, pledge adviser, scholarship adviser.

The adviser piece is the most challenging for us nationally. As the initiative grows in number of chapters, the need for advisers grows 5 times as fast. Consequently, the General Fraternity is putting a large effort into recruiting and training prospective advisers. We are having quite a bit of success in having alumni advise chapters that are not their alma mater and using non-Betas (FOB's—Friends of Betas). FOB's are proving to be a fascinating resource. They are stimulated and enthusiastic about the Men of Principle Initiative and become very committed to helping our chapters. Of course, they are excluded from ritual events but otherwise their counsel has been excellent.

Men of Principle chapters are winners on their respective campuses. They typically rank high in scholarship, campus leadership and intramural sports. Men of Principle chapters are growing in membership year-on-year while the General Fraternity (and the collegiate fraternity system in general) is experiencing declining membership. New colonies (and thus new chapters) of Beta Theta Pi are started only as Men of Principle chapters. When Theta returns to OWU, it will be as a Men of Principle chapter. One of the prerequisites will be to find a core of 5 advisers to get it started. So as we look to that day, we need to be identifying and training potential advisers.

This year's Beta Convention will be in Oxford on the Miami campus. One of the activities offered is adviser training for which expenses are paid. If you are interested in becoming an adviser for Beta, either for Theta in the future or for a chapter near you, please contact me at martyh@fortemgt.com.
