Together, We Have Made It Happen Theta Chapter Once Again Up and Running

Brother Betas, it gives me great pleasure to finally be able to communicate with the Theta Chapter alumni through this newsletter. It gives the present actives the chance to express our utmost appreciation for alumni support while also alerting you to our trials and tribulations while we try to rebuild this once mighty chapter of Beta to its previous level of prominence.

Starting from scratch has been a difficult task. When we moved into the house in the fall of 1987, we had no bylaws, furniture or financial backing, which caused chaos and disunity. Our division made it difficult to channel our ideas toward a productive goal. We had many leaders and few followers. The executive members of our house had been young, inexperienced and without the credible backing of bylaws. Things have changed. The election of new executive members has brought age, experience and the development of crucial bylaws.

Kirk Keller '91 (treasurer), Jim Stilwell '91 (secretary), Roger Ward '92 (vice president) and I have been active members since at least 1988. We have held many positions in the house and are well-experienced in the financial, social, philanthropic and parliamentary aspects of the house. Already we have worked hard to pass needed bylaws on the selection of roll numbers, the approval of financial budgets, the setting of penalties for late payment of house bills, and the creation of an in-house disciplinary action committee to hear all grievances within the house. Leadership is much more productive when there are credible laws to back our authority. A house that was slipping into a chasm of disunity has rapidly transformed into a productive unit that can finally be denoted by the term brotherhood.

Our major difficulty of late has been one of numbers. We have trouble attracting as many quality men as we need in rush; our small numbers make it a Herculean task to double our membership. Perhaps the greatest problem has been the lack of funds that we were able to raise for rush. Fortunately, our House Corporation has granted us \$2,500 for next year's rush in addition to our own resources. The increased rush funds will enable us to be more creative than we have been in the past. I have also requested that the general fraternity send a representative to conduct a rush workshop the week before rush so that those who are unfamiliar with rush know what to expect and how to attract and maintain rusher interest in Beta. With the core of our house becoming seniors next year, we realize how gravely important it is to have a very successful rush next year. We are viewing rush as a do-or-die situation, and would greatly appreciate any ideas that our alumni might have for us.

The University has made a drastic change in the Greek system that I think will greatly benefit Beta. At the request of President Warren, fraternity rush has been moved to the first two weeks of the spring semester. A 2.0 grade point average during fall semester is an eligibility requirement for rush. Being a house with high academic standards, I feel that this new clause will immensely improve our chances of attracting the men we want as Betas. All houses have suddenly become equal, with no houses having any experience with a spring rush. Since we are still in the development stages of creating a successful rush, I believe that we are at an advantage because of our adaptability. The larger houses that have been relying on a very structured fall rush program to attract pledges may have difficulty developing a creative rush in the spring. Our increased rush funds, coupled with our flexibility to easily change our rush program, may enable us to be a strong competitor next year.

RISK MANAGEMENT POLICY OF BETA THETA PI

The risk management policy of Beta Theta Pi includes, but it is not limited to, the following provisions which shall apply to all fraternity chapters, colonies and all levels of fraternity membership.

1. The possession, use and/or consumption of ALCOHOLIC BEVERAGES by any fraternity member or guest while on chapter premises, during an official fraternity event, or in any situation sponsored or endorsed by the chapter must be in compliance with all applicable laws of the state, province, county, city, university or other controlling governmental entity.

2. Abuse of the consumption of ALCOHOLIC BEVERAGES, by any fraternity member or guest while on chapter premises, during an official fraternity event, or in any situation sponsored or endorsed by the chapter, shall be prohibited.

3. To accomplish the policies stated in one (1) and two (2) above, the following prohibitions are adopted but are not meant to be inclusive:

A. No fraternity member, collectively, or individually, shall purchase for, serve to, or sell alcoholic beverages to minors (i.e. those under legal "drinking age").

B. No alcoholic beverages may be purchased through the chapter treasury nor may the purchase of same for members or guests be undertaken or coordinated by any member in the name of or on behalf of the chapter.

C. No chapter may co-sponsor or co-finance a function where alcohol is purchased by any of the host chapters, groups or organizations.

4. The possession, sale and/or use of any ILLEGAL DRUGS or CONTROLLED SUBSTANCES at any chapter house, sponsored event or at any event an observer would associate with the fraternity, is strictly prohibited.

The General Fraternity has also reaffirmed its strict anti-hazing and sexual abuse policies.

Any chapter that does not obey these policies is subject to suspension of its charter by the General Fraternity. Any individual, undergraduate or alumnus who violates these policies personally assumes all liability for the consequences of the act. The fraternity insurance programs will not stand behind violators of any of these policies.

Undergraduate Feature: Mike Colson '91

Mike Colson '91 pledged Theta Chapter in the fall of his freshman year. "I'm glad that I joined Beta when I did," Colson said. "I have always been proud of the fact that I have been associated with Beta for as long as I could be. I think experience counts for a lot in an organization."

Since his activation, Brother Colson has served the fraternity as secretary in 1988 and vice president and scholarship chairperson in 1989. Although the executive positions of president, vice president, treasurer and secretary are set for his last year at Ohio Wesleyan, Colson still hopes to hold a high position in the house. "I believe that each brother should focus part of his energy on Beta every year that he is an active part of it," Colson said.

Colson is an English literature major. "I am not quite sure what I am going to do with it (his degree), but I'm sure that I will find something that I will enjoy," he said. "English majors tend to be versatile and capable of handling lots of different things."

Colson's cumulative grade point average of 3.88 places him among the top students of the University. He has also been a member of the varsity track and cross country teams for three years. He said that running was a good way to break up all the book-reading and paper-writing.

In his sophomore year he gained All-Conference honors in both indoor and outdoor track.

Colson finished second in the 1,000-yard run in the 1989 indoor championship, then placed third in the 10,000-meter run in the 1989 outdoor championship. "It isn't hard to figure out that 1,000 yards and 10,000 meters are completely different distances," said Colson. "The key is doing a lot of distance training - that prepares you for anything."

Colson hopes to specialize in the mile and the half-mile in his senior year, as he did in the John F. Kennedy High School in Wheaton-Glenmont, Md., where he still lives.
