Dear Brothers:

I am probably one of the few alumni who lives so far away and yet enjoys reading about the "comeback" of the chapter.

I was very impressed to read the letter sent to you by Don Cooper '68 and his reasons for sending such a letter. If what Don says is correct, then you have finally overcome the hurdle of mediocrity and begun your journey back to excellence. The Beta House, when I joined, was an architectural wonder, and its occupants, leaders in scholastics and very strong competitors in extra-curricular activities.
