This spring Theta chapter's I.M. softball team, resembling the 1954 Brooklyn Dodgers, came out to crush all opponents on its way to the fraternity softball crown. Special recognition should go to Craig (Dave Kingman) Cano '79, Steve (Wingnut) Glensell '79, and Bruce (Boon) Warshaw '78. Pitcher Dick Thomas compiled an 8-2 record on the mound for the team. Captain Tom David '78, game after game turned in a performance reminiscent of former Pirate great Joe Garigiola for his brillance in the field. Scanlon was 16th in batting in the O.A.C. southern division batting a hefty .346, while Rosenfeld was one of the key pitchers for the Bishops and lead them to an important victory over Marietta in the last game of the season. The Bishops finished second behind Marietta by a half game.

Theta chapter has also created two new sports which have caught on around campus. One of which is Lacrosbie, a combination of lacrosse and frisbie; the game uses all of the rules of lacrosse but with a frisbie as the point tallying object. Our chapter is presently seeking to have the game introduced into the I.M. program here next spring.

In non-sporting events, Theta chapter is sponsoring a Bike Marathon and an Eating contest. The proceeds of which will go to the Delaware County Needy Children's Fund in memory of Fred Myers, long time and great soccer coach at Ohio Wesleyan who died suddenly this past January.


