Theta House Co. Meets October 22nd; Plans Made For Membership Directory

At a meeting of the Theta Chapter House Company at the chapter house in Delaware, October 22, a decision was made by the board of trustees to proceed immediately with plans for a complete chapter membership directory.

This major project has been under consideration for some time, since indications have been that the alumni membership is solidly in favor of and will show support of this first-ever comprehensive membership listing.

The directory, which will be ready for mailing to all alumni members by next spring, will include the following sections: an alphabetical listing of all living initiates, complete with home and residence addresses, occupational information and telephone numbers; a geographical section, broken down by state and city or town; a class listing; and a deceased listing. The publication will be "coat-pocket-size" for ease of handling.

Of course, the directory will be a complete success only if all alumni members cooperate in seeing that their own individual entries are correct. Enclosed with this issue of our alumni newsletter is a "directory information card." We urge you to immediately supply the information requested and return to our alumni records office. If you wish your entry to be correct, don't delay!

Leading to the decision to publish the membership directory was the announcement that the alumni dues support program, to date, has proven to be more successful than in past years. The response to the first mailing was most encouraging. However, it is anticipated that many more alumni will determine to support our alumni program, particularly in light of the upcoming directory.

The trustees also determined to publish the customary three issues of "Theta Data" this year. The alumni corporation is in good financial state, at the moment, and with anticipated increased alumni support, we should be able to meet our (Continued on page 2)

Beta continues to be dominant in Ohio Wesleyan varsity athletics, with brothers Thomas A. "Tim" Bell, Buenos Aires, Argentina, and James R. Kaminsky '68, Gloversville, N.Y., leading the way.

Jim excels in both track and cross-country. Last spring he was named "athlete of the week" for his track performances. He holds the Ohio Wesleyan record in the three-mile run, with a time of 15:26.4, has run a 4:23.7 mile and has a record of 3:10 for a three-quarter mile time trial. This fall, Jim led the OWU cross-country team to a surprising seventh place finish in the All-Ohio Championships and third in the separatelyscored college division by covering the five-mile course in 26 minutes, 31 seconds.

Tim received his second "athlete of the week" award this fall for his tremendous performance in the Bishops 6-2 soccer win over strong Miami. He scored two goals in the contest to lead a second-half comeback that enabled him to move into second place among scoring leaders in the Ohio Collegiate Soccer Association. A junior, Tim has been a starter since his freshman year.
